RESCUE MISSION for **OBPs & Friends**

The Orange-bellied Parrot is close to extinction with less than 20 wild birds. Without federal government funding this species will become extinct in the wild. Very soon.

Federal government funding for OBPs finished last June

Over the last six years there has been a major decrease in funds for the environment from the Australian Government¹. While the Tasmanian and Victorian Governments have committed over \$3 million over the next four years to the Orange-bellied Parrot, the Australian Government stopped funding last June. Critical actions for the OBP are not happening because of this.

For OBPs to survive an extra \$1 million p.a. for 5 years is needed²:

1. To increase reproductive success

Support research and field activities by ANU Difficult Bird Research Group (currently donating their time) and Tasmanian Government DPIPWE to increase reproductive success at Melaleuca including intensive nest monitoring to understand causes of success.

2 To increase food availability in SW Tas with timely burning program OBPs rely on recently burnt moorlands for food and there has been no recent burn at the only breeding area. A shortage of wild food is linked to nest failure.

3. To establish new breeding sites

Release of Orange-bellied Parrots at new sites where food is available (i.e. areas recently burnt) and monitor nests to maximize breeding success.

The Orange-bellied Parrot is not the only threatened species

There are 1700 nationally listed threatened species. Threats to species and their habitats include land clearing, invasive species, fragmentation (islands of bush in cleared landscape) and climate change.

There are solutions:

- Increase funding from the Australian Government for threatened species from \$80 million per year to \$250 million per year¹. This increase to be part of a new Fund for Nature of \$2 billion per year.
- 2. Pass stronger national environmental laws with the Australian Government taking full responsibility for the natural environment³.
